Composition: 50 mM Tris Base / Tris-HCI, 25 mM EDTA, 500 mM Sodium Chloride, 3 mM Magnesium Chloride Hexahydrate, 3 mM Beta-Mercapto Ethanol, 0.1% Nonidet P-40 Substitute, 1% Sodium Dodecyl Sulfate(SDS), pH 8.0 ± 0.15 . Prepared in 18.2 megohms water and filtered through 0.22-micron filter.
