**Composition**: 200 mM Bis-Tris Propane [1,3-bis,tris(hydroxymethyl) methylamino propane], pH 7.0  $\pm$  0.15. Prepared in 18.2 megohms water and filtered through 0.22 micron filter.

# 4.1 Description of first aid measures
