Composition: 0.3% Peptone, 0.5% Yeast Extract, 137 mM Mannitol, pH 7.0 ± 0.2. Prepared in 18.2 megohms-cm ± 1 water and autoclaved at 15 psi (121°C) for 30 minutes on liquid cycle.
