Composition: 1.8% Tryptone, 0.5% Soy Peptone, 85 mM Sodium Chloride, 14 mM Potassium Phosphate Dibasic, 13.8 mM Dextrose, 44.5 mM Agar, pH 7.3 ± 0.2. Prepared in 18.2 megohms-cm ± 1 water and autoclaved at 15 psi (121°C) for 30 minutes on liquid cycle.
