Composition: 1.75% Peptone from Animal Tissue, 0.3% Beef Extract Powder, 0.15% Potato Starch, pH 7.3 ± 0.2. Prepared in 18.2 megohms-cm ± 1 water and autoclaved at 15 psi (121°C) for 30 minutes on liquid cycle.
