Composition: 45 mM Tris Base, 45 mM Boric Acid, 1 mM EDTA Disodium Dihydrate, 1% Agarose, pH 8.3 \pm 0.15. Prepared in 18.2 megohms-cm \pm 1 water and autoclaved at 15 psi (121°C) for 30 minutes on liquid cycle and/or filtered through 0.22-micron filter.
