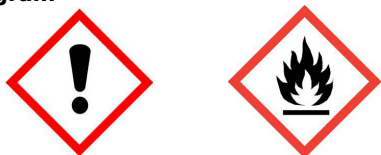

**4.1 Description of first aid measures**

**General advice:** Consult a doctor and show this safety data sheet.
