Composition: 1.37 M Sodium Chloride, 530 mM Potassium Chloride, 1 mM Calcium Chloride, 6.25 mM Magnesium Sulfate, 11 mM Sodium Phosphate Dibasic, 11 mM Potassium Phosphate Monobasic, 61 mM Dextrose, 1 mM Phenol Red, pH 7.4 ± 0.15. Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.

4.1 Description of first aid measures
