SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS

Composition: 100 mM Sodium Chloride, 3.7 mM Potassium Chloride, 1.2 mM Magnesium Sulfate, 1.37 mM Calcium Chloride Dihydrate, 28 mM Sodium Bicarbonate, 20 mM Sodium Lactate, pH 7.4 \pm 0.15. Prepared in 18.2 megohms-cm \pm 1 water and filtered through 0.22-micron filter.
