Composition: Mixture of 10 mM Tris Base and Tris-HCl, 340 mM Sucrose, Calcium Chloride 3 mM Dihydrate, 2 mM Magnesium Chloride Hexahydrate, 0.1 mM EDTA, 0.5% Nonidet P-40 Substitute, pH 8.0 \pm 0.15. Prepared in 18.2 megohms water and filtered through 0.22-micron filter.
