**Composition:** Mixture of 20 mM Tris base and Tris-HCl, 250 mM Lithium Chloride, 0.5% Sodium Deoxycholate, 0.5%, Nonidet P-40 Substitute, pH 7.9 ± 0.15. Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.
