Composition: Mixture of 10 mM Tris Base and Tris-HCl, 10 mM Sodium Chloride, 3 mM Magnesium Chloride Hexahydrate, 30 mM Sucrose, 0.5% Nonidet P-40 Substitute, pH 7.0 ± 0.15. Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.
