**Composition:** 5 % BSA in 0.05% Tween-20 and 0.02% Sodium azide in PBS (10 mM Sodium phosphate dibasic, 2 mM potassium phosphate monobasic, 2.7 mM KCl and 137 mM NaCl), pH 7.4 ± 0.2. Prepared in 18.2 megohms water and filtered through 1-micron filter.
