SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS

Composition: 0.5% Tween-20 in 500 mM Tris-HCl (mixture of Tris base and Tris HCl), 1.5M NaCl pH 7.6 \pm 0.2. Prepared in 18.2 megohm water and autoclaved at 15 psi for 30 min on liquid cycle. Tween-20 was added after the 10X TBS preparation.
