Composition: Mixture of 50 mM Tris Base and Tris-HCl, 150 mM Sodium Chloride, 0.05% Tween-20, pH 7.4 ± 0.15. Prepared in 18.2 megohms-cm ± 1 water and autoclaved at 15 psi (121°C) for 30 minutes on liquid cycle.
