SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS

Composition: Diatrizoic Acid (106.91 g/L) and Polysucrose 400 (181 g/L), density $1.077 \pm 0.01\text{g/ml}$ at 20 degree Celsius and pH 7.0 ± 1.0 . Prepared in 18.2 megohms water and filtered through 0.22 micron filter. Lymphocyte Separation Medium is provided as a sterile iso-osmotic solution consisting of diatrizoic acid and polysucrose for the in vitro isolation of lymphocytes from whole blood.
