SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS

Composition: 20 mM Sodium Citrate Dihydrate, 2.2 mM Citric Acid, 23 mM Sodium Phosphate Monobasic, 61 mM Dextrose, 2.2 mM Adenine, 70 mM Sodium Chloride, pH < 7.0. Prepared in 18.2 megohms-cm±1 water and filtered through 0.22-micron filter.
