**Composition:** 10 mM Sodium phosphate dibasic, 2 mM potassium phosphate monobasic, 2.7 mM KCl, 137 mM NaCl, and 0.1% digitonin, pH 7.4 ± 0.2. Prepared in 18 megohms water and was filtered using 0.22 micron filter.
