**Composition:** 200 mM Sodium phosphate dibasic, 40 mM potassium phosphate monobasic, 54 mM KCl, 2.75 M NaCl, 2% Tween-20 and 0.02% Kathon, pH 7.6 ± 0.15. Prepared in 18.2 megohm water and filtered through 1-micron filter.
