**Composition:** Mixture of 500 mM Tris Base and Tris-HCl, 2.75 M Sodium Chloride, 54 mM Potassium Chloride, 2% Tween-20, 0.02% Sodium Azide, pH 7.6 ± 0.15 (1X). Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.
