**Composition:** 10% Donkey Serum, mixture of 50 mM Tris Base and Tris-HCl, 150 mM Sodium Chloride, 0.05% Tween-20, 0.02% Sodium Azide, pH 7.4 ± 0.15. Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.
