Composition: Mixture of 20 mM Tris Base and Tris-HCl, 5 mM Magnesium Chloride Hexahydrate, 100 mM Potassium Chloride, 0.02% Gelatin, 0.9% Nonidet P-40 Substitute, 0.9% Tween-20, pH 8.3 ± 0.15 (1X). Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.
