SECTION 4 - FIRST-AID MEASURES

4.1 Description of first aid measures

6.1 Personal precautions, protective equipment and emergency procedures: Do not take action without suitable protective clothing - see section 8 of SDS. Evacuate personnel to safe areas. Ensure adequate ventilation. Avoid breathing vapors, mist, dust or gas.

6.2 Environmental precautions: Do not let product enter drains.

6.3 Methods and materials for containment and cleaning up: Cover spillage with suitable absorbent material. Using non-spark tools, sweep up material and place in an appropriate container. 7.1 Precautions for safe handling: Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing. Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.

7.2 Conditions for safe storage, including any incompatibilities: Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Keep in a dry place. Moisture sensitive. Hygroscopic.

7.3 Specific end use(s): Use in a laboratory fume hood where possible.
