**SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS**

**Composition:** For preparation and maintenance of E. coli, 1.0 % Tryptone, 0.5% Yeast Extract and 0.5% NaCl, pH, ~7.2. Prepared in 18.2 megohms water and sterilize by autoclaving at 15 psi pressure (121 degrees C) for 30 minutes.
