### **SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS**

**Composition:** 1.0 % Trypton, 0.5% Yeast Extract, 1% NaCl, and 0.15 % Tris-HCl. Dissolve 25 Capsules/L in water, adjust pH, ~7.2. Prepared in 18.2 megohms water and sterilize by autoclaving at 15 psi pressure (121 degrees C) for 30 minutes
