### **SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS**

**Composition:** 147 mM Sodium Chloride, 4 mM Potassium Chloride, 3 mM Calcium Chloride Dihydrate, pH 7.4 ± 0.15. Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.
