SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS

Composition: 100 mM Sodium Chloride, 3.7 mM Potassium Chloride, 1.2 mM Magnesium Sulfate, 1.3 mM Calcium Chloride Dihydrate, 28 mM Sodium Bicarbonate, 20 mM Sodium Lactate, pH 7.4 ± 0.15. Prepared in 18.2 megohms-cm ± 1 water and filtered through 0.22-micron filter.
