SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS:

Sterile, certified DNAse/RNAse free deionized water (18.2 megohm-cm \pm 0.2) was treated with 0.01% DEPC and incubated at 37 degree Celsius for 12 hr. DEPC treated water was autoclaved for 2 hours at 15 psi on liquid cycle to inactivate DEPC. Store at room temperature.
