**Composition:** Ultra-pure Sodium lauryl sulfate/Sodium Dodecyl Sulfate (SDS), EDTA and other RNase inactivation agents were used. Prepared in 18.2 megohms nucleases free water and filtered through 0.22 -micron filter. We recommend gloves and protective glass during handling the reagent.
